Remarks:

1. Parents are free to choose the venue while training time will be determined by the School.
2. New students must attend the ability test held on 12 Mar. Existing students will be exempted.
3. If a student, through testing, is considered not suitable for group learning, the parent may consider applying for one-to-one private tutorial. For details please contact the School.
4. **Last date for application is 8 March 2017.**

The Teachers

All teachers are holders of 'Special needs water sports teacher's certificate' granted by the School.

No of Intakes

The maximum number of students is 40 to 50. The School reserves the right to accept any application.

Fee

\$1,300 per 10 lessons.

Successful applicants for "needy families assistance programme" the fee will be reduced by half i.e. \$650 (for 10 lessons)

Needy Families Assistance Programme

The programme is to finance families including those CSSA families, families receiving Community Care Fund, or students whose family is facing unexpected events. Needy family may apply and provide the following information:

1. Family under CSSA or receiving community care fund to furnish "SNC03_17 form" and attach a copy of the certificate
2. Family facing unexpected events to furnish "SNC03_17 application forms" and "needy families assistance programme application form".

Applicant should note:

- a. Family facing unexpected events must be referred by a registered social worker, principle or teacher (referral agent) where the student is studying;
- b. Applicants concealing information or making false misrepresentation will be required to pay back the subsidy granted by the School.
- c. The School reserves the right to determine if an applicant is eligible for fee reduction
- d. The School reserves the right to amend, add, delete, interpret the rules and the decision to approve an application.
- e. An eligible student who failed to attend for 8 or more sessions will not be allowed to apply for the scheme again.

Payment Method

By crossed cheque make payable to "The Hong Kong Swimming Teachers' Association Limited".

How to Submit Application

Mail the filled-in the application form together with a cheque of \$1,300 to the School at Flat A, 3/F, Shung Lan Mansion, 37 Leighton Road, Causeway Bay, Hong Kong Swimming Teachers' Association by **no later than 8 Mar 2017**.

*note that postage \$1.7 applies only to the weight of 30 grams and size of messages less than 245 mm x165 mm. Underpaid letter may be detained by the post office, this Council will not supplement fee to the post office to receive.

Points to Note

Students unable to attend due to illness, if a medical certificate is submitted, will not be considered as absent.

Students attend all the 10 lessons will be allowed to participate in the next phase of the course.

About the Swimming Pool

1. Warm Water System

Swimming pool with warm water system, annual average water temperature to keep at 30-33 degrees Celsius.

All are indoor swimming pools, the water and the room are maintained at constant temperature.

2. Other Facilities

Swimming pool provides a wide range of teaching materials to meet the needs of different age and level of student

Swimming pools are equipped with platform and moderate depth, suitable for all kinds of swimming classes

Swimming pool with the spectator stands for the convenience of parents watch

Fee includes admission charges for the parents and students

3. Changing Room

Heated lamps kept the locker room at appropriate temperature

Cold and hot water showers

The rooms are cleaned regularly and being kept in a clean and tidy condition

The Course

The Pools

The swimming pools are only for use by the School at the about mentioned periods.

No substitute lesson will be provided for those absentees irrespective if medical certificates are provided. If parent considers his/her child not suitable for the course he/she may withdraw and a refund will be made for the lessons yet to be held.

The teacher-student ratio: depending on student background and schedule, is up to 1:6.

Safety and Hygiene

During the swimming lessons, swimming pools there are stationed with sufficient qualified lifeguards .

Swimming pools are equipped with platform and moderate depth, suitable for all kinds of swimming classes

Topics will include self-help skills and enable students to learn less self survival

Periodic inspection and change the water in a pool, ensure that the water quality conforms to government standards

The water quality is monitored regularly by the swimming pool owner.

Monitoring Progress

Each student is required to attend professional assessment prior to enrollment, including health, physical and mental behavior etc.

Parent or guardian is also required to participate in interviews prior to enrollment, understanding the teaching plan

An assessment will be conducted at the end of the 10 lessons.

Students with good performance may be recommended to join the Hong Kong Sports Association for the mentally handicapped to undergo further training. Outstanding students may also have the opportunity to represent Hong Kong in international competitions.

To enable parents to understand more effectively the swimming class and dealing with queries of parents, Hong Kong swimming teachers Association will arrange for specialist is responsible for communicating with parents to enhance communication efficiency.
